INTRODUCTION OF THSC

THSC is a Not-for-Profit Organization, registered under the Societies Registration Act, 1860, promoted by the National Skill Development Corporation (NSDC) & Confederation of Indian Industry (CII) with inclusive representation of the Government, Industry, Industry Associations and Training Institutes across India.

BACKGROUND AND RATIONALE FOR Expression of Interest

As it is evident, Tourism Sector is extremely crucial for the development of the country's youth and health as it is a strategic sector having a multiplier effect and bearing on the growth of the overall nation as well. The sector in India presents unique opportunities and challenges with deficit of skilled manpower because of which the productivities and efficiencies in the sector are low. This has serious economic and strategic implications for the country. Out of the few key sectors identified by NSDC, THSC Sector is one of the key sectors where planned skill development with consistent standards of performance is required to increase production, improve productivity as well as quality of jobs and products.

THSC, through this Expression of Interest (EOI), would select Training Partner, Center, Institutions, Agency (referred as Bidder/Proposer in the rest of the document) with relevant experience and capacity to work on the scope of EOI and maintain information thereof.

OBJECTIVE OF THE PROJECT

The Objective of this EOI is to undertake training in physical mode for employment linked, entrepreneurship development & recognition of prior learning for approved job roles of THSC. The selected Organizations would be responsible for delivering approved Qualifications of THSC.

Guidelines for Applicants who wish to apply for the Expression of Interest

- a. Training Partner must be affiliated / empaneled with THSC before the application date.
- b. Applicant must have conducted skill development training in hospitality in for STT or RPL.
- c. Applicant must have a Turnover of Minimum 0.50 Crore in the last FY or cumulative turnover of Minimum 2 Crore in Last 3 FY.
- d. Pool of Certified Trainers or eligible Trainers for TOT.
- e. Has been present in Skill Development space for over 3+ years.
- f. Special preference is to be given to University/Colleges/PSU/Industry Partners who are operating in the LWE, Border Areas, SC/ST/OBC/EWS candidates RTD etc schemes.
- g. Special preference to be given to partners who in the past have conducted training under the HSRT scheme. (Each applicant to attach previous WO of HSRT)
- h. Each applicant applying for the project will require to deposit Application Fees of INR 1 lakhs (all inclusive) per Applicant. (This is only valid for selected applicants).
- i. Each Applicant must secure min 60 marks in the presentation for qualifying in the schemes.
- j. Allocation of numbers must be as per marks attained.
- k. Training Partners undertaking the Employment linked training must be ready to provide placement to a minimum of 80% of the certified candidates and retain them for 90 days with necessary proof.
- l. THSC will deduct an Admin Cost of 1% on the total billing amount for each TP.

Format to make the Presentation. (Slide numbers are tentative. It can be increased or decreased to move in sequence.)

1. Write up about the company with all necessary information such as incorporation certification experience, total numbers, schemes, financial statement (turnover) etc. / CA Certificate.
2. Management profile / team profile
3. Past and total experience related to Hospitality Job Roles – Schemes, Numbers, Placement, Attach all Work Order / Sanction Letter.
4. TOT Certificates or attach CV of relevant trainers.
5. Affiliation certification for all Training centers
6. Training Center photos (relevant photos of class & lab only for hospitality job roles). Attach list of all proposed centers with number of class, lab, area in sq ft, TC ID
7. If affiliation certificate is not available in case of PSU / IP / University / Colleges – Incorporation certificate or other relevant documents to be attached.
8. Relevant LoI of the companies agreeing to provide placement to students.
9. If Partners have previously done training under Hunar Se Rozgar scheme, then attach the WO, Previous Performance (Trained – Certified – Placed)
10. Training information on RTD, LWE Area, Border Area, Women Specific Training, Special CSR schemes, Special Projects (Prisons) etc. Tribal, SC, ST, OBC, EWS Candidate training
11. Placement photos
12. Other relevant information (Pls add as much as information can be in the slide).
