OFFICE ORDER

Subject: NSQC composition for NSQF alignment process under NCVET- reg.

The National Council for Vocational Education and Training (NCVET) was notified vide Gazette Notification no. SD-17/113/2017-E&PW dated 5th December 2018. The notification lays down that, “the National Council Vocational Education and Training constituted under paragraph 2 will subsume the existing National Council for Vocational Training (NCVT) and National Skill Development Agency (NSDA)”.

2. Paragraph 16 under Chapter 3 of the notification lays down that one of the major functions of NCVET is to frame guidelines for the approval of qualifications and approve qualifications in the manner set out in such guidelines.

3. Since NSDA was subsumed in NCVET with effect from 31st July 2020, the process for NSQF alignment through the National Skills Qualification Committee (NSQC) is now under NCVET. The NCVET in its meeting held on 21st July 2020 approved the following composition of NSQC for the NSQF alignment process in NCVET:
